Youth Social Exclusion and Lessons from Youth Work. Evidence from literature and surveys (by European Commission)

This paper aims at offering evidence about the situation of social exclusion suffered by young people in the European Union, and the positive effects that youth work initiatives produce in fostering their (re)inclusion. Looking at factual information on the main conditions of exclusion is essential to have an accurate understanding of the threats encountered by young people.

Available data and research literature illustrate the major reasons behind the marginalisation of young Europeans, and pave the way to the development of effective policy strategies to prevent it.

Deadline 11/07/2013

The EU Drugs Strategy 2005-2012 set targets for all EU drug-related activities to attain a high level of protection, well-being and social cohesion by preventing and reducing drug use, dependence and drug-related harms to health and society.

The EU Action Plan on Drugs 2009-2012 translated these targets into a list of concrete actions to reduce the prevalence of drug use among the population and to reduce the social harm and health damage caused by drugs. Proposals shall complement the efforts of the EU in the area of drug prevention and information.

Call for tender n° EAHC/2013/Health/08 concerning Effective Recruitment and Retention Strategies for Health Workers.

Deadline June 7, 2013

The aim of this call for tender is to have a study which will provide a comprehensive analysis of effective strategies for the recruitment and retention of health professionals to assist and enhance the development of human resource policies through the exchange of good practices.

There are three main objectives:

- to provide a comprehensive analysis of effective strategies for recruiting and retaining health workers in the EU;

- to facilitate a discussion with experts and stakeholders to canvass expert opinion and to foster the exchange of good practice; and
- to propose options for future action on the recruitment and retention of health professionals at the European level.

The maximum volume of this call for tender is 400 000€.

International Day Against Homophobia and Transphobia (17/05/2013)



On this occasion, the Fundamental Rights Agency (FRA) presents the results of its survey 'European Union lesbian, gay, bisexual and transgender survey'. To mark IDAHO 2013, a conference hosted by the Dutch government in The Hague gathered more than 700 participants among which ministers, NGOs and representatives from EU institutions and international organisations.

The European Commission proposes to improve application of workers' rights to free movement

The European Commission has proposed measures to ensure the better application of EU law on the right of EU citizens to work in another Member State.

The proposal, if approved by the European Parliament and Council, would help to ensure real and effective application of existing legislation. Member States would be required to:

- create national contact points providing information, assistance and advice so that EU migrant workers, and employers, are better informed about their rights

- provide appropriate means of redress at national level
- allow labour unions, NGOs and other organisations to launch administrative or judicial procedures on behalf of individual workers in cases of discrimination
- give better information for EU migrant workers and employers in general.

WHO mental health action plan 2013 – 2020

The Health Assembly approved a resolution on WHO's comprehensive mental health action plan 2013-2020– the first action plan on mental health to have been put forward by WHO. The plan's four major objectives are to: strengthen effective leadership and governance for mental health; provide comprehensive, integrated and responsive mental health and social care services in community-based settings; implement strategies for promotion and prevention in mental health, and strengthen information systems, evidence and research for mental health.

The plan sets important new directions for mental health including a central role for provision of community based care and a greater emphasis on human rights. It also emphasizes the empowerment of people with mental disabilities and the need to develop strong civil society and health promotion and prevention activities. The document proposes specific actions for Member States, international, regional and national level partners, and the Secretariat.

It also proposes indicators and targets such as a 20% increase in service coverage for severe mental disorders and a 10% reduction of the suicide rate in countries by the year 2020 that can be used to evaluate levels of implementation, progress and impact.
